Unless for unforeseen reasons or due to a holiday the Ohio Valley Trades & Labor Assembly, AFL-CIO meets the 2<sup>nd</sup>

Affiliated Local Unions in good standing shall be entitled to active and or retired representation based on per capita tax paid to  
the West Virginia AFL-CIO and according to the following schedule: 50 members or less -- **2 delegates** / 51-100 members --  
**3 delegates** / 101-200 members -- **4 delegates** / 201-400 members -- **5 delegates** / 401-700 members -- **6 delegates** --  
701-1,100 members -- **7 delegates**. One delegate for each additional 500 members or any fraction thereof, above 1,100.

**NOTE:** When Local Unions choose CLC representation, active members should be given preference over retired members.

A union retiree club/chapter shall be admitted as an affiliate of the Council with one (1) delegate. Where two or more  
union retiree clubs/chapters desire to affiliate with the Council and are eligible to do so, that affiliation shall be through a  
council of union retiree clubs/chapters. A Union Retiree Council shall be entitled to three (3) delegates, regardless of the  
number of union retiree clubs/chapters within the Union Retiree Council.

Constituency groups that are approved and recognized by the AFL-CIO, including the Alliance for Retired Americans (ARA)  
shall be entitled to one (1) delegate.
